About

The EcoArts Nexus is an online repository that compiles extensive knowledge at the intersection of the arts and the environment from various fields and practices. It includes resources such as examples of funding schemes for cultural adaptation and artistic practices addressing environmental issues, tools and guidelines, literature, awards, as well as initiatives, projects and organisations dedicated to connecting art and culture with the environment. Divided into 15 categories, the repository currently features over 250 entries. It serves as a living map, detailing the landscape of philanthropic institutions, public funding sources, the art world, and the cultural sector – all united in their commitment to addressing the urgent environmental challenges of our time. By being a continuous work in progress, we invite you to share and present your practices if they are still not included in this online archive.

The Kultura Nova Foundation initiated this repository of knowledge in arts and culture, environment and funding, within the framework of the Philea Arts and Culture Funders Forum (ACFF) and in collaboration with the Fondation Daniel et Nina Carasso.

At its core, the EcoArts Nexus is instrumental in gathering and disseminating information crucial for understanding and navigating the complex relationships between environmental policies, funding strategies, capacity-building programmes, and the development of green tools and guidebooks tailored specifically for the arts and culture sectors. It is a vast pool of reports, resources and data essential for different actors looking to foster a deeper engagement with environmental sustainability within their arts and cultural practices.

Beyond its function as a comprehensive data repository, the EcoArts Nexus aspires to play a transformative role in the cultural and environmental sectors. Its primary goal is to significantly enhance the visibility of current practices that merge ecological concern with cultural expression, thereby inspiring and motivating a broader spectrum of actors to embrace and drive positive change towards carbon-neutral cultural sector. Through showcasing innovative practices and facilitating access to a wealth of resources, this repository aims to foster efforts that not only address environmental urgencies, but also highlight the unique role of the arts and culture in advancing sustainable futures.

Offering open access to all its resources, the EcoArts Nexus is designed to be an adaptable and continuously growing document. It invites ongoing contributions and updates, welcoming new data, insights, and resources. By doing so, it serves the immediate needs of its users and contributes to a broader understanding of how the arts and culture can intersect with environmental sustainability to foster a more ecologically conscious and culturally vibrant world.

Being developed and curated under the supportive umbrella of the Philea Arts and Culture Funders Forum, the EcoArts Nexus represents an important example of the power of collective effort. The initiative benefits from the collective expertise of its main contributors, the Kultura Nova Foundation and the Fondation Daniel et Nina Carasso, with valuable additional contributions from Porticus and other philanthropy organisations in sharing data. Policy

The "Policy" section assembles a diverse collection of cultural policy documents which include public policy documents from international organisations, national and subnational bodies and philanthropic institutions, as well as advocacy and strategic documents aimed at influencing policy frameworks. Despite their varied origins, these documents all share a unified goal: to connect the realms of culture and art with environmental considerations.

Culture 21: Actions. Commitments on the role of culture in sustainable cities

“Culture 21: Actions” was approved in 2015 in Bilbao during the first Culture Summit of UCLG. This document renews the commitments of United Cities and Local Governments to highlight the interdependent relationship between citizenship, culture, and sustainable development. “Culture 21: Actions” supplements the Agenda 21 for Culture, and transforms it into concrete commitments and actions. It aims to be an international guide that is applicable worldwide and that promotes knowledge. It facilitates the exchange of good practices, and strengthens a global network of effective and innovative cities and local governments. Among its nine Commitments, Culture and Environment incorporates a list of specific actions that guide the work of local governments linked to Agenda 21 for Culture and which promote processes of self-evaluation leading to better fulfilment and more effective implementation of public policies and strategies.

European Cultural Heritage Green Paper “Putting Europe’s shared heritage at the heart of the European Green Deal”

The paper correlates the contribution of cultural heritage to all key areas of the European Green Deal, including Clean Energy, Circular Economy, the Renovation Wave, Smart Mobility, Farm to Fork, Green Finance and a Just Transition, Research and Innovation, Education and Training, as well as Green Deal Diplomacy. It proposes a series of concrete recommendations both for policy-makers and for cultural heritage stakeholders. Potential conflicts, real or perceived, between heritage safeguarding and European Green Deal action are also identified, as well as win-win strategies for overcoming these conflicts.

Funder Commitment on Climate Change

Launched in 2019, the Funder Commitment on Climate Change (FCCC) presents a comprehensive and overarching framework that empowers funders across diverse fields of expertise, primarily within the UK, to actively contribute to addressing the root causes and consequences of climate change. Comprising six pillars of action (Education and Learning, Resource Allocation, Integration, Investment Stewardship for a Post-Carbon Future, Operational Decarbonisation, and Progress Reporting), this commitment provides foundations with a robust structure to effectively combat climate change. Signatories commit to aligning their strategies with climate considerations and making specific pledges in order to support initiatives and address climate-related challenges financially. In 2023, the FCCC unveiled its third report, detailing the endeavours undertaken by signatories across these pivotal pillars. This report underscores the ongoing enhancement of existing initiatives. It outlines the strides made, particularly by new signatories, as they embark on their journey to make tangible progress in all areas.

Global Call to Put Cultural Heritage, Arts and Creative Sectors at the Heart of Climate Action

The Climate Heritage Network (CHN) is a voluntary, mutual support network of government agencies, NGOs, universities, businesses, and other organisations committed to tackling climate change and achieving the ambitions of the Paris Agreement. The network was launched in 2019 and works to reorient climate policy, planning, and action at all levels to account for dimensions of culture, from arts to heritage. ‘Culture at the Heart of Climate Action’ is a global call to the UNFCCC to include cultural heritage, the arts and creative sectors in climate policy. The initiative is asking for a ground-breaking Joint Work Decision on Culture and Climate Action, a UN process which would trigger policies and frameworks to enable culture to contribute fully to climate solutions. A JWD would launch a process to: understand how culture is already supporting climate actions and solutions; support cultural voices to influence audiences and consumers; unite the entire culture sector globally to scale up action on the most pressing issue of our time; influence key policies and discussions on adapting to the changing climate, decarbonising, supporting cultural knowledge keepers, safeguarding heritage and culture, and innovating with creativity.

Green Arts Charter

The Green Arts Charter aims to help cultural organisations with their sustainability goals, to enable collective action, and establish shared goals and pledges.

The charter aligns with the Creative Carbon Scotland training programme to support organisations to deliver the pledges and commitments within the charter, alongside its growing online network to encourage peer-to-peer learning.

The charter runs parallel with and is connected to Creative Scotland’s criteria for funding programmes where organisations are asked about their environmental sustainability commitments or, in some cases, to report on their emissions and have a carbon management plan.

How sustainability and culture reinforce each other: “Culture Natural” recommendations

The Council for Culture is a statutory body entrusted with advising the Dutch Government and Parliament on matters related to the arts, culture, and media. It provides recommendations regarding cultural policy in the Netherlands, whether solicited or not. In 2023, the Council published a report titled “Cultuur Natuurlijk. Hoe duurzaamheid en cultuur elkaar versterken”, highlighting the potential synergy between sustainability and culture. However, it underscores the urgent need for a significant push to expedite sustainability efforts within the cultural sector. This advisory report targets the cultural sector, municipalities, provinces, national cultural funds, and

the relevant ministries. The Council for Culture's recommendations aim to expedite the sustainability transformation within the cultural sector and elevate culture's role in broader societal sustainability initiatives. It acknowledges that, like many other sectors, the culture sector has yet to achieve climate neutrality and circularity.

The scope of culture in this report encompasses the arts, heritage, creative industry, and the media, both subsidised and unsubsidised. Advice is directed at the cultural sector and various governmental bodies, including pertinent ministries and national cultural funds, emphasising the nexus between sustainability and culture.

Towards sustainable arts: European best practices and policies

In seven chapters, experts from the Czech Republic, Finland, Flanders, Germany, the Netherlands, Scotland and Spain investigate how cultural organisations in their own countries are becoming more sustainable, how artists are engaging with the climate crisis, and the role of culture in the general transition towards a greener society. While each chapter contains many inspiring initiatives and ideas unique to each country, there are also striking similarities. In most countries, sustainability is absent from national cultural policy, and culture is absent from climate policy. There is however a need for sustainable cultural policy: among other things to counter fragmentation of initiatives, to enhance collaboration or to offer funding, support and financial security. Another significant observation underlying all contributions is the importance of collaboration and of networks, which have achieved great results in the countries included in the publication. Funding: Cultural Adaptation

The "Funding: Cultural Adaptation" section pertains to the financial and non-financial support given to individuals, groups, organisations, and institutions in arts and culture allowing them to embrace sustainable practices and adapt their operational and programme-related endeavours to environmental sustainability. These grants include adopting eco-friendly measures in buildings and venues, transportation, energy usage, water conservation, waste management, travel practices, materials selection, equipment utilisation, sustainable arts productions, and many others.

An individual and collective support system, operational in Spain and gradually implemented in France. This non-financial support is an additional way to strengthen the impact and transformation capacities of the foundation's partners – subsidised grantees, and to build a more ecological, inclusive, and fulfilling society.

Climate balances in cultural institutions

Art and culture are crucial in creatively shaping the carbon-zero transformation process and making it tangible through artistic exploration. However, artists and cultural institutions face challenges, such as limited funds, bureaucratic structures, and insufficient knowledge to implement concrete ecological measures. To address these issues, a pilot project serves as a model for creating a climate balance in the cultural sector, providing institutions with an instrument to strive toward climate neutrality. Supported by a nationwide pilot project, 19 cultural institutions from diverse sectors took part in creating a climate balance sheet and assessing their carbon footprint.

Over four months, participating institutions received support in accounting to gain transparency on their CO2 emissions, and specific climate coaching to enhance their environmental practices. Additionally, the project explored how ecological sustainability can be better integrated into the German Federal Cultural Foundation funding system, encouraging broader ecological impact in the cultural sector.

Environmental Programme

In 2012, Arts Council England and Julie's Bicycle jointly launched the first-of-its-kind Environmental Programme. This programme was designed to support the cultural sector in addressing the challenges of climate and nature crises. Fostering literacy, confidence, and leadership skills empowers cultural professionals to take proactive measures against climate change.

The ambitious Environmental Programme is tailored for National Portfolio Organisations, Investment Principle Support Organisations, and the broader creative and cultural sector. The activities of NPOs and IPSOs primarily revolve around decarbonisation, resilience, justice, and governance. The programme equips NPOs and IPSOs with environmental reporting tools and initiatives, helping them

better understand their impact and reduce their ecological footprint. However, the programme aims to go beyond mere reporting and encourages the cultural community to collaborate in taking meaningful and collective action to combat climate change. Additionally, the programme offers an educational Board Environmental Champions programme benefiting board members, and a Leading Resilience programme.

The wider creative and cultural sector can actively participate by gaining free access to training, resources, carbon calculators, and guidance tailored for individual practitioners to support environmental action. Some key activities include transforming energy usage, striving for net zero energy buildings, becoming capital investment-ready, sharing knowledge, and showcasing best practices from different sectors. The programme also offers free carbon calculators, regular training events, workshops, multimedia resources for the enhancement of climate justice understanding, a resource library, and an annual report featuring benchmarking information, news, and case studies.

The Environmental Programme encourages the creative and cultural community to contribute to a sustainable and environmentally conscious future by providing these resources and opportunities.

This support empowers leaders to address environmental concerns and implement practical, sustainable solutions. It provides complementary assistance to project leaders who have received financial support through various calls for projects. Encouraging active participation in the ecological and solidarity transition enables organisations to contribute on their scale to the UN Sustainable Development Goals (SDGs). The programme offers methodological support from the National Union of CPIEs (Centres permanents d'initiatives pour l'environnement), in collaboration with the Fondation de France. Additionally, participants gain access to an extensive network of experts. The support provided is fully tailored to each organisation's needs as they discuss the duration, focus areas, and actions collaboratively with their teams and experts.

Fonds Zero

The Fonds Zero programme addresses the often-overlooked climate impact of art while aiming to empower cultural actors in Germany to actively contribute to overcoming the climate crisis. Call For Destruction (Bando Distruzione)

Daylight and fresh air

This grant is dedicated to projects bringing more daylight and fresh air into everyday life. Applicants are encouraged to propose original ideas to move indoor activities outside, thus fostering a healthier and happier environment. Applicants can be citizens, private and public groups, neighbours or classmates, with ideas for utilising spaces like school yards, forests, harbours, and cities for outdoor activities. Take Me to the River

The Goethe-Institut and the Prince Claus Fund's multimedia exhibition Take Me to the River curated by Maya El Khalil, showcases selected works from various countries, including Egypt, Ecuador, Colombia, Mexico, and Congo. Cultural professionals, artists, architects, and designers worldwide are addressing the challenges of climate change while engaging their communities. Their work opens up creative spaces that raise awareness on environmental shifts and potential solutions to counter the climate crisis. These works include film, photography, VR video, audio-visual archives, and community radio. Since 2018, the joint funding programme by the Goethe-Institut and the Prince Claus Fund has supported over 35 art and culture projects from around the world addressing global environment changes. Take Me to the River presents 15 of these projects online, highlighting voices against resource depletion, environmental exploitation, and violations of indigenous rights. The exhibition was presented online as a response to the coronavirus pandemic, and it weaves each individual project into narratives that explore nature's rights, environmental abuse, nature's imagined prosecution, human-induced natural disasters, and the complex impact of climate crisis. Additional funded works will be added to the presentation in the future, creating an online archive.

The need for training related to green practices was identified through a membership survey, which highlighted the members' lack of sufficient knowledge to start a green transition in their organisations or daily work. IETM hosted three online sessions of the Green School, focusing on greening tools, sustainable climate justice, creation and production, as well as an in-person info session at their plenary meeting and interactive Toolbox sessions to deepen the concepts. In the summer of 2023 IETM published an open call intended for IETM members only, for an extensive autumn training programme with the purpose of guiding the participants through development of their own green transition project proposals. The training programme was two-months long and consisted of a series of workshops, peer working sessions and coaching. Together with experts and through peer-to-peer learning, participants explored different aspects of green transition, received practical knowledge of how to use various greening tools, such as environmental calculators, or how to support sustainable production and creative processes, content and stories. The training was customised to the needs of selected participants' proposals. Selected participants received a €500 stipend for the time they dedicated to the Green School, disbursed upon completion of the training.

Leading Resilience

Leading Resilience is a new training and mentoring programme designed to bolster the resilience of NPOs against future climate changes. It is divided into two distinct strands: Organisation and Place. Under the organisation strand, the initial year will see two cohorts of senior leaders acquire essential skills and knowledge to adapt and respond to climate change, then incorporate them into their organisations' strategies and operations. In the subsequent years, the focus shifts to the place strand, where three place-based partnerships will be identified to receive valuable practical support in adapting to climate change. These partnerships will collaborate closely with local networks, seeking innovative and pragmatic solutions to the challenges posed by the changing climate.

Transforming Energy

Expanding on the previous Spotlight programme, Arts Council England and Julie's Bicycle developed the Transforming Energy programme to empower cultural organisations to embrace energy efficiency and sustainable practices. The Transforming Energy programme offers a unique opportunity for cultural organisations to take meaningful action in combating the climate crisis and becoming leaders in the sector. With a specific focus on decarbonisation for building-based organisations, the programme is structured into two dynamic strands of activity: Buildings Net Zero Energy and Capital Investment Ready. The first strand, Buildings Net Zero Energy, is designed to support building-based organisations within Arts Council England's National Portfolio Organisations (NPOs) and Investment Principles Support Organisations (IPSOs). It caters to organisations in various stages of their sustainability journey, whether they are just beginning to work on energy reduction or eager to intensify their efforts. Participants receive expert guidance, self-service

resources, assistance from technical partners (Pilio), energy management webinars and training sessions facilitated by Julie's Bicycle to implement energy monitoring, improve controls, and upgrade energy efficiency, progressing towards Net Zero Energy. The second strand of the programme focuses on nurturing smaller cohorts of organisations that have already made significant strides in energy reduction. These forward-thinking organisations receive tailored coaching, mentorship, and peer-sharing opportunities to become Capital Investment Ready. By empowering them to transition key cultural venues to low-carbon solutions, they will be better positioned to take advantage of future funding opportunities dedicated to sustainability in the cultural sector.

MA Regenerative Design

According to Daniel C. Wahl, in the context of a fast-accelerating climate and biodiversity emergency, sustainable design is not enough. Over the past few decades, the integration of environmental considerations in the design process has focused on strategies such as more efficient use of natural resources (such as zero waste design) or the reduction of our environmental impact (using less toxic materials or carbon-neutral design). Regenerative Design goes beyond sustainability and actively contributes to restore and replenish what human activities have radically deteriorated. This course proposes to engage with an online community of designers studying from their local contexts to develop an action research project in regenerative design and actively contribute to holistically restore their local biosphere, taking endemic cultures and indigenous voices into account and socio-cultural tenets as is appropriate.

Tools

The "Tools" section encompasses digital resources crafted to increase environmental sustainability and drive climate action, particularly within the arts and culture domain. These resources serve as aids for artists, arts institutions, and cultural organisations of varying sizes to assess and comprehend the carbon and environmental impact of their endeavours, spanning venue management, touring, mobility, production, events, festivals, transportation, and others. Green tools provide actionable components for professionals across diverse artistic disciplines and cultural domains, empowering them to combat climate change and advocate for environmental sustainability. These tools are conceived and established within pioneering initiatives that foster connections between the arts and sustainability, encouraging and enabling endeavours and presenting strategic avenues to amplify systemic change and transformation of daily behaviours, operations, and programming in the arts and culture realm.

Carbon'Clap

Carbon'Clap is a carbon calculator for the film and TV industry developed by Ecoprod. With Carbon'Clap, users can measure the carbon footprint of an audiovisual, film, or advertising project. By entering physical and financial data into the tool, users can assess the quantity of greenhouse gas emitted for the production of their project and identify the activities with the highest impact. A better understanding of the carbon footprint of production can guide choices and strategies to avoid and reduce greenhouse gas emissions. Carbon'Clap also allows users to report their carbon footprint to stakeholders such as broadcasters, co-producers or film funds, which can compile the data of all their projects in the company dashboard. This feature is made available exclusively to Ecoprod members. Carbon'Clap was created by Ecoprod in 2012 and updated in 2017. In 2022, Ecoprod launched a complete tool redesign to update calculation methodology and modernise the user experience. The tool was designed and developed with industry stakeholders and environmental experts. Carbon'Clap is available free of charge to professionals and companies in the audiovisual, film, and advertising sectors. The tool was certified by the CNC in March 2023 and is backed by leading French broadcasting agencies and producers.

Carbon management tools

Carbon management tools include four spreadsheet-based tools which allow cultural professionals and organisations to integrate their emissions recording and planning work. These tools are for internal use. They are based on the most up-to-date carbon emissions conversion factors provided by the UK Government (BEIS) in 2022. They provide a carbon footprint output unit of kgCO₂e (all greenhouse gases calculated as carbon dioxide equivalent), in line with all UK planning and reporting requirements. The four tools encompass:

A carbon management planning tool that integrates existing records with new planning work to help users identify and assess reduction projects while keeping track of their emissions.

A quick carbon management calculator that allows users to quickly calculate the emissions of specific actions to reduce their energy consumption, travel, waste, and water consumption. It can help them decide on the lowest carbon action to take or measure a snapshot of their practice. It also includes a guide to typical equipment usage.

A CMP summary tool that collates costs and emissions savings resulting from user reduction projects over the three years of their CMP.

A carbon budgeting tool that enables organisations to use their current carbon footprint and net zero target to forecast and budget their carbon emissions in line with their net zero trajectory. This is an advanced tool and should only be used once organisations have calculated their carbon footprint, understood all their sources of emissions, and set a net zero target year.

Decolonial Toolkit for Climate Artists

The Decolonial Toolkit for Climate Artists addresses the intersection of colonialism, climate change and the arts. The Toolkit aims to help artists consider their own cultural conditioning, confront the inseparability of colonialism and climate change, and develop a decolonial foundation for both the climate art field, and the arts sector more broadly. Ecoprod Label

The Ecoprod Label was created in 2022 to provide a common framework to define green production. Over 100 companies, including major production companies and the major French broadcast agencies, have signed a common statement in December 2022 committing to using the tool in their productions. The Ecoprod label lists actions for each department, from script to post-production, to help reduce their environmental impact and enable producers to self-assess their production by measuring their sustainability score, certify their production and be awarded the ECOPROD LABEL. To be eligible for the Ecoprod Label, a production has to meet all the mandatory requirements (blue criteria), reach a score of at least 65%, and be audited by AFNOR Certification.

Festival Fuel Tool

Festival Fuel Tool is a simple tool that rates the fuel consumption of your event and compares it with industry benchmarks. It is intended as a guide – all events are unique, and there may be good reasons for differences. However, research indicates that most UK events could save up to a third on fuel bills.

All data remains anonymous and will not be disclosed to any third party. By using this tool, users contribute to aggregate data which will be used to improve industry benchmarks for environmental reporting to chart the industry's progress. Julie's Bicycle, acting on behalf of the industry collective Powerful Thinking, collects and stores data according to the Data Protection Act. Julie's Bicycle

possesses access to the data entries for aggregation, irrespective of the hosting website for the Fuel Tool. Any party beyond Julie's Bicycle can access published, anonymised, aggregated data.

OnMaterials

Launched in December 2018, OnMaterials emerged as a pilot project within the START – Create Cultural Change programme. Its main objective was to heighten sustainability awareness in artistic production, fostering waste reduction through material redistribution and creative reuse. By actively engaging artists, designers, craftsmen, art institutions, schools and exhibition spaces, the project aims to collaboratively develop innovative strategies to promote sustainable cultural practices. In Athens, post-event handling of leftover materials from cultural gatherings is infrequent. Installations and artwork materials are often discarded or stored for extended periods. The founders of the project advocate for a departure from our linear “take-make-discard” relationship with materials. This inspired the repurposing of these materials for fresh artistic endeavours, an avenue to re-conceptualise cultural practices in a more sustainable way. This initiative underscores the feasibility of alternative production and consumption systems. Early integration of material reuse in event planning can transform substantial waste into a valuable resource. Artists and designers can use this platform to find the materials they need or to offer the surplus materials they no longer require.

Theatre Green Book

Created during the Covid-19 lockdown, Theatre Green Book UK is an unincorporated association established by several leading theatre organisations in the UK which have come together in a unique partnership, building upon grassroots initiative by many individuals and organisations. Currently, the initiative is led by three UK national theatres and membership organisations (the Association of British Theatre Technicians, the Society of London Theatre/UK Theatre, and Theatres Trust, the national advisory body for theatres). The focus of the initiative is to create, in collaboration with leading sustainability experts, a comprehensive common standard for making theatre sustainably. At the moment, 2nd version of the book has been published by the initiative. This version is offering toolkits, guidelines, case studies, educational materials, and the possibility for theatres to register and monitor their process. The book content was developed in regards to three specific areas of theatre making: sustainable productions (setting common standards for sustainable ways of producing shows), sustainable buildings (structurally adapting theatre buildings to climate emergency) and sustainable operations (covering everything else theatres do, from catering to rehearsals, offices to travels). New editions are expected in the future. The ambition for Theatre Green Book is for all theatres in the UK to achieve Theatre Green Book baseline standards across building operations and productions by the end of 2026.

European Green Festival Roadmap 2030

The European Green Festival Roadmap 2030 was developed by YOUROPE as part of its three-year project Future-Fit Festivals (3F) in collaboration with A Greener Future (AGF) and Greener Events Norway as well as YOUROPE's GO Group (Green Operations Europe) think tank. The guidelines are based on the requirement of the EU Green Deal: cutting emissions by at least 55% by 2030 while also considering the UN SDGs and industry requirements. The European Green Festival Roadmap 2030 helps the festival sector to identify appropriate measures to fight emissions and other harmful environmental impacts, set clear goals, and think significantly and long-term. The Roadmap provides a comprehensive framework for the ambitious sustainable improvement of cultural events, from management structures to specific practical measures in the various action fields of the creation and production process. This is the first pan-European publication jointly developed and published by and for the festival sector. It can serve as a relevant tool for organisers of festivals and other significant (open-air) events, including far beyond the borders of the EU.

#PhilanthropyForClimate: Implementation Guide

The Implementation Guide is published by the global movement #PhilanthropyForClimate within the International Philanthropy Commitment on Climate Change. The International Philanthropy Commitment on Climate Change calls for all foundations to act on the climate emergency regardless of their mission, status, or geographic location. The signatories of the International Commitment pledge to take action under the seven pillars of the Commitment, for which this Implementation Guide outlines and suggests actions. Designed to inspire and support foundation signatories as they embark on their journey of change, it is divided into seven sections, one for each pillar. Each unit includes additional detail to better grasp its importance, and suggests actions at three levels: Getting Started, Building Momentum, and Demonstrating Leadership. These are offered as a choice of options, not a list of requirements.

SHIFT Eco-Guidelines for Networks

The “SHIFT Eco-Guidelines for Networks” targets the ecological footprint of international cultural networks and platform organisations. These guidelines serve as a reference for network organisations seeking to minimise their environmental impact, while encouraging sustainable practices, and setting an example for their members and peers. The guidelines are openly accessible and intended to drive structural change within the cultural sector. Tailored for cultural network organisations, they address various aspects of environmental impact, encompassing operations, policies, activities, and governance. Special emphasis is placed on areas such as travel and events, which are significant sources of carbon emissions. The SHIFT Eco-Guidelines, initiated by the SHIFT partners and developed in collaboration with the Green Leisure Group and Creative Carbon Scotland, represent a crucial step in addressing the lack of environmental certification options. They are structured as ecolabel guidelines, and have the potential to evolve into a certification scheme for cultural network organisations (as of 2023, organisations can obtain SHIFT Culture Eco certification). Participating organisations need to comply with the SHIFT Eco-Guidelines on which the certificate is based, and consider the capacity required to implement all the mandatory norms. Along with taking the necessary time to implement the guidelines, organisations need to build a relationship with a buddy organisation, prepare for and attend a dedicated workshop, carry out a self-review and a peer review for their buddy organisation and undergo an external audit. The certificate implies commitment to the scheme for a minimum of two years.

Beyond Green: The Arts as a Catalyst for Sustainability

The Salzburg Global Seminar edition “Beyond Green: The Arts as a Catalyst for Sustainability” (February 19 to 24, 2016) took up the question of the arts’ role in advancing sustainability at international, national, and local levels. The goals of this session were to build on path-breaking initiatives that are advancing cross-sectoral links between arts and sustainability around the world, encourage bolder efforts, and recommend strategic approaches for taking innovative grassroots initiatives to scale for more significant, longer-term impact. Sixty arts-based practitioners and thinkers committed to promoting social, economic, and environmental sustainability gathered in Salzburg in February 2016. Participants from 27 different countries included artists, designers, architects, creative entrepreneurs, politicians and policymakers, environmentalists, urban planners, educators, scientists, game developers, philanthropists, scholars, and business leaders. Attendees represented a broad spectrum of cultural expression and artistic endeavour (including visual and performing arts, literature, cultural heritage, food, fashion, architecture, and design) and came from diverse arts organisations, including theatres, music organisations, museums, and cultural heritage groups, as well as business start-ups, academic institutions, national and international policymaking bodies, and advocacy organisations.

Engaging Live Music Audiences On Climate Change Through Travel Campaigns

Reducing emissions from audience travel is a music industry-wide challenge. In a 2022 report, researchers Briony Latter and Adam Corner made recommendations for communicating more effectively with audiences on sustainable travel choices, and leveraging the cultural influence of events to create wider change. In 2023, working with five UK festival and venue partners, these ideas were trialled and tested in a project supported by the Calouste Gulbenkian Foundation. Researchers explored different approaches to messaging about sustainable audience travel that could be scaled up and used for music gigs, festivals and other events. Across the partnerships, results showed that messages led to increases in the use of shuttle buses, public transport and active travel, a reduction in car use, and an increase in social media engagement.

This report, which culminates a year and a half of dedicated work, constitutes an integral component of the ambitious French Economic Transformation Plan (PTEF). Launched by The Shift Project in spring 2020, the PTEF represents a far-reaching research endeavour in various sectors to identify concrete measures for achieving carbon neutrality in France by 2050. The PTEF's methodology hinges on analysing tangible data, encompassing energy consumption, meal servings, and fleet sizes. A systemic approach unites approximately ten sectors to pinpoint the decarbonisation strategies needed for the upcoming five-year period (2022 – 2027) and the overarching 2050 target. In response to the lack of physical data and in order to formulate practical measures that take into consideration on-the-ground realities and cultural diversity, this report incorporates insights from nearly a hundred interviews with professionals from the cultural sector. As a result of substantial collective engagement within the sector, this publication outlines the critical energy and climate challenges confronting the sector. Additionally, it highlights decarbonisation pathways commencing in 2022 to bolster resilience. The core objective of this report centres on decarbonising the cultural sector, thus ensuring its adaptability in the face of future energy and climate disruptions. It is an invaluable guide for industry professionals, comprehensively evaluating the climate impact and fossil fuel dependence within French culture. This report is the fruit of a collaborative effort orchestrated by Samuel Valensi, initiated by Anaïs Roesch, and supported by Fanny Valembois, Juliette Vigoureux, Valérie Bonnard, and Jean-Noël Geist. Héloïse Lesimple contributed to its development, with Erwan Proto providing input on costings. Earth Speakr: Carbon Footprint Report

Over several years, Julie's Bicycle and Studio Olafur Eliasson have engaged in a collaborative effort to assess the environmental repercussions of various art installations, including Waterfall at Tate Modern in 2019, Ice Watch at Tate Modern and Bloomberg London in 2018, and an earlier iteration of Ice Watch during the 2015 global climate talks in Paris. This report serves to illuminate the climate change impact of the Earth Speakr project. It specifically examines the project's physical and digital implications from October 2019 to December 2020, encompassing its developmental phase and the initial six months of its existence. Earth Speakr is a digital platform that invites young people to speak up for the planet and the future they want and to make their messages heard. The artwork was co-created with children and young people. It consists of a playful app, an interactive website, an AR (augmented reality) experience, and audiovisual presentations in the 24 official languages of the European Union. Olafur Eliasson created this artwork on the occasion of the German Presidency of the Council of the European Union 2020 from July to December 2020 with the support of the German Federal Foreign Office.

Greening the Creative Europe Programme: Final Report

The European Commission published the study “Greening the Creative Europe programme” to help achieve its objective of fighting climate change and to support its efforts to make the Creative Europe Programme more environmentally-friendly. Cultural and creative activities can support the transition to a green economy by promoting sustainability and environmental awareness. At the same time, the programme itself will strive for carbon neutrality by promoting sustainable means of transportation and environmentally responsible behaviours. Heritage in Climate Planning – A Pilot Project for Understanding the Inclusion of Culture in Climate Actions

Heritage in Climate Planning (HiCLIP) is a project undertaken within the Climate Heritage Network to support mainstreaming the

cultural sector in climate planning. Cultural resources can be man-made artistic artefacts and material heritage (historic buildings, landscapes, museums, etc.) significant to a community, nation, or humanity. They also include intangible elements such as living cultural expressions, traditions, knowledge, and skills that provide humans meaningful linkages with their surroundings, whether urban, rural, or natural. This report presents the results of a pilot project that assessed the governance treatment of cultural resources and the role given to the cultural sector in nine climate plans from eight countries covering national, regional, and municipal levels of governance. It also highlights potential areas for culture and heritage to become more effective in Climate Action policy and planning. The multidisciplinary research process and practices presented in this report identify some of the cognitive biases at the base of sector planning that may prevent efficient collaborations.

Culture-Sustainability Relation: Towards a Conceptual Framework

Several individual scholars and international organisations have attempted to conceptualise culture in its different meanings in sustainability. Despite those efforts, a tangle of different approaches is being used, reflecting the various disciplines and policy aims. The authors of this paper propose an interdisciplinary framework for identifying the different roles of culture in sustainability, in an attempt to guide the research and policy activities in this complex field. The framework comprises three representations defined by a literature review on cultural sustainability, which are further explored through eight organising dimensions that mark the similarities and differences between the three representations. The article reveals that the three representations are partly interlinked and that they also reveal gradients in the dynamics of the system, as well as in the human/nature interface.

Low Emission Festivals

The Low Emission Festivals (LEF) is an initiative led by A Greener Future (AGF) and supported by Ecotricity, LIVE, Association of Independent Festivals, and participating festivals. LEF aims to amplify good actions, tools, and resources, speed up the adoption of solutions, and identify obstacles and opportunities to change both the energy mix and the culture of powering events. In 2019, a study by Hope Solutions and Zap Concepts, with support from AGF, AIF, Julie's Bicycle, and Powerful Thinking, showed that UK outdoor events were creating the equivalent of half a million tons of CO2 emissions in unnecessary fuel burn yearly. Since then, much work has been done to make improvements with increased guidance, awareness, and solutions, but there is still a long way to go. The first step of LEF's new initiative is research: gathering information and data from UK festivals and power providers. The organisation is currently completing a power data survey with several early adopter festivals and power contractors to analyse the impact of actions on fuel consumption and opportunities for further reductions.

Institute of Radical Imagination

The Institute of Radical Imagination (IRI) is a nomadic think-tank that brings together experts from various fields, including political scientists, economists, lawyers, architects, hackers, activists, artists, and cultural producers, to define and implement post-capitalist zones in Southern Europe and the Mediterranean. It focuses on legalising common resources, radical pedagogy, labour commoning, rethinking citizenship, common space and architecture, and alternative economies. IRI addresses pressing issues by generating ideas, applied knowledge, and practical tools within existing academia, art, and activism networks. IRI participated in the World Congress for

Climate Justice in Milan in October 2023. They aim to create a platform for discussion among anti-capitalist climate activists and intellectuals worldwide to define a common agenda in the context of eco-social struggles. They are organising an assembly to co-write the “Art for Radical Ecologies Manifesto” involving various participants from the art and activism domains. This manifesto emphasises the role art plays in fighting for climate justice and new ecologies, highlighting the potential of art to challenge extractive capitalism and to promote radical creativity within the social sphere. The workshop explores themes such as addressing climate crises through art, activist art forms, and the ways in which art contributes to redefining human-nonhuman relationships in new ecologies.

Their primary objective is to inspire and engage audiences in environmental issues, elevate awareness, and stimulate action in response to climate change and other environmental challenges. These projects aim to serve as dynamic and captivating platforms for addressing intricate environmental topics while fostering collaboration among artists, environmental organisations, and communities to advance environmental sustainability.

Récits et imaginaires croisés des socioécosystèmes (Crossed narratives and imaginaries of socio-ecosystems)

“Crossed narratives and imaginaries of socio-ecosystems” is a participatory and transdisciplinary art and science research project coordinated and co-led by TranSborder platform and Zone Atelier Brest Iroise – INEE / CNRS. The research applies methodologies of “participatory science” in its aim to explore possible common cultural ecology practices which will be capable of dealing with transitions and transformations the world is going through in the context of climate crisis sensitively, but also concertedly. The topics of interest include the preservation of biodiversity and integration of species (humans and non-humans) in the future and their coexistence in specific environments and territories. To address these challenges, the research is taking place at the Rade de Brest and the islands of the Iroise Sea, includes several different stakeholders (scientists in marine and environmental sciences, managers, artists and local residents) and develops a series of experimental, transdisciplinary activities in order to create bridges and establish a dialogue between art, science and society: sensitive mapping and modelling, workshops and consultations, land-based residences, exhibitions and installations, seminars, workshops and conferences.

A Sea Change 2022-2024

Started in June 2022, A Sea Change is dedicated to fostering creative innovation within “blue economy” practices through interdisciplinary and intermedia arts and artistic and curatorial research. Since 2022, partners and collaborating organisations have engaged with diverse communities to catalyse positive impact on the environment, marine ecosystems, and the well-being of coastal populations. The project focuses in particular on addressing the pressing challenges of the “blue economy” at both local and European levels. The activities developed by A Sea Change (workshops, artist residencies, public programmes, documentary screenings, and educational initiatives) are designed to promote and facilitate changes within local environments. They also generate new works of art and interdisciplinary collaborations, contributing to developing a more sustainable, diverse, and inclusive Mediterranean. Culminating in a 2024 exhibition in Barcelona, this project unfolds across multiple locations including Croatia, Cyprus, Greece, and Spain. The

project spans various sectors, encompassing environmental sciences, health, tourism, and design, and features a series of exhibitions in multiple countries. A Sea Change is an international collaborative project led by KONTEJNER (Croatia) in partnership with MOMus – Experimental Center for the Arts (Greece), NeMe (Cyprus), and the Quo Artis Foundation (Spain). The project is co-funded by the European Union.

Climate Visuals

Climate Visuals is the world's only evidence-based and impact-focused climate photography resource. It hosts new research, an image library, and international open calls. Since 2016, the collection has grown to host over 1,400 Creative Commons and Rights Managed images – all content that embodies the evidence-based “7 Climate Visuals principles”. These images are publicly available to browse in the Climate Visuals library. Registered users can browse and access content that is ‘rights ready’ for their profile and needs – searching by keywords, country, theme, collections, date, licence type, and source. Users can generate links directly to images for sharing on social media, and, with lightboxes, they can also save, download, and collaborate on their image selections.

Earth Speakr

Earth Speakr is an artwork. Through an app that was active from 2020 to 2022, the artwork invited kids to speak up for the planet and adults to listen to what they had to say. All the kids' messages can be heard on the Earth Speakr Map. The Earth Speakr website hosts and celebrates over 10,000 messages recorded by kids about our planet's future – brilliant, funny, and heartbreakingly honest messages. It is a testament to the importance of listening to the next generations, as we adults make crucial decisions that inevitably affect their future. Earth Speakr is a digital platform that invites young people to speak up for the planet and the future they want and to make their messages heard. The artwork was co-created with children and young people. It consists of a playful app, an interactive website, an AR (augmented reality) experience, and audiovisual presentations in the 24 official languages of the European Union. Olafur Eliasson created this artwork on the occasion of the German Presidency of the Council of the European Union 2020 from July to December 2020 with the support of the German Federal Foreign Office.

Green Inversions

In 2023, twelve artists from the Republic of North Macedonia in collaboration with two mentors – Christian Tschirner aka Soeren Voima (dramaturg, playwright, director, educator from Germany) and Lynn Takeo Musiol (dramaturg, playwright, director, educator from Germany) realised an online and offline playwriting workshop in Skopje, intended for professional theatre practitioners and writers. The workshop focused on green dramaturgy through topics related to climate change. The authors opened the following local environmental problems which were transformed into short dramatic texts and narrations (using different the structures of realism, absurd, surrealism, dramatic poetry, etc.): crude capitalism and getting rich by reselling and burning toxic waste, people with deeply damaged health due to polluted air, soil, food and stress.

ITAC IMPACT: Climate

ITAC IMPACT: Climate is a framework through which teaching artists can design and lead projects in their local communities to positively impact the climate crisis using teaching artistry to raise awareness, educate others, activate participation, and ultimately change minds and behaviours. The initiative was piloted in March 2021 by commissioning five teaching artists in different parts of the world to undertake a creatively engaging project with their local communities, addressing a local climate challenge and enabling participants to be agents of change. The projects are supported by a science ambassador, a world-respected climate expert who provides scientific context and informs the evaluation and learning. Based on the discoveries from the artist’s community-engagement projects, ITAC developed an online curriculum and a 20-hour teaching artist course to be soon published online on kadenze. A second edition was launched in 2022, and the third in 2023.

This project was initiated by the International Teaching Artists Collaborative (ITAC), a worldwide collaboration, proactively networking artists through international conferences, virtual collaboration, and social media to build an international community, cultivating excellence in teaching artistry.

Net Zero: Heritage for Climate Action

In this multi-level capacity development project, ICCROM (International Centre for the Study of the Preservation and Restoration of Cultural Property) sought on-the-ground implementation of heritage-based mitigation and adaptation strategies to reduce the impact of climate change on people and heritage. The field experience fed into international training for change agents and community leaders. A final international symposium and publication served as catalysts to inform policy and expand the project's outreach by sharing the know-how on heritage for climate action in 25 to 30 countries suffering from acute environmental stressors. This project started in January 2022 and ended in December 2023.

PROSPER: PROtotype for Sustainable residencies in PERipheries

Peripheries are places of solidarity that partners in PROSPER aim to explore by creating connections between environmentally vulnerable regions, through a series of transnational cultural collaborations. The main priorities are to engage artists and local communities in two regions with major environmental significance: the island of Evia in Greece, which suffered destructive wildfires in 2021, and Lake Ohrid in North Macedonia, which has suffered degradation due to human activity endangering its endemic importance. The objectives of the project are to contribute to the development of enhanced international cultural collaboration, methodologies of integrating environmental issues into artistic practice, stronger collaboration between art and tourism, empowered local audiences,

RE-IMAGINE Green Art Practices on the Margin

RE-IMAGINE Green Art Practices on the Margin is a project that focuses on the green transformation of the performing arts sector in the Balkan region and Central Europe. It was initiated by Green Art Incubator (Serbia), Pro Progressione (Hungary), Lokomotiva (North Macedonia) and Arte Urbana Collectif (Bulgaria). Over the course of two years, the project seeks to redefine the social role of performing arts organisations as agents of environmental change by building capacity within organisations and professionals in the field to achieve goals related to reducing CO2 emissions and achieving zero-waste production. RE-IMAGINE gathers civil society organisations working in Serbia, North Macedonia, Hungary, and Bulgaria as an example of peripherality in the performing arts (both in geopolitical and sectoral terms), which makes their green transformation even more complex and challenging. To meet this goal, among other activities, the project consortium designed an extensive residency programme, RE-IMAGINE Green. The programme is foreseen to equip participants with comprehensive knowledge and skills in climate literacy, and ecologically sustainable approaches to project development and implementation in performing arts. The project is co-funded by the Creative Europe programme of the European Union and will run from 2023 to 2025.

SHIFT – Shared Initiatives for Training

Calouste Gulbenkian Prize

The Gulbenkian Prize for Humanity, established in 2020, is dedicated to acknowledging individuals and organisations at the forefront of addressing today's most pressing global challenge: climate change. It recognises outstanding efforts in climate action and solutions that instil hope. The annual prize, amounting to one million euros, is directed toward supporting those who are most severely affected by climate change and facilitating the expansion of climate-related initiatives. Annually, on the 20th of July, coinciding with the date of the founder's passing, the Calouste Gulbenkian Foundation pays tribute to its founder through a series of ceremonies culminating in the presentation of the Calouste Gulbenkian Foundation Prizes. The Gulbenkian Prize for Humanity specifically aims to honour individuals,

groups, or organisations from around the world whose contributions to climate change mitigation and adaptation are distinguished by their originality, innovation, and impact.

COAL Prize

The COAL Prize celebrates contemporary artists actively engaging with ecological issues and championing sustainability. Each year, a panel of experts shortlists ten outstanding projects from a global pool of submissions received through an open call. These ten projects undergo rigorous evaluation by a jury comprising representatives from partner organisations and renowned experts in art and ecology. All applications considered by COAL and the selection committee automatically become part of an artist network, potentially leading to future opportunities and collaborations within COAL and its partner initiatives. The COAL Prize winner is honoured with a financial grant and a residency at the Domaine de Belval, which the François Sommer Foundation manages. This estate, nestled in the scenic French Ardennes within the commune of Belval-Bois-des-Dames, serves as an observation centre for rural life and wildlife. It hosts artists each year, recognising their invaluable contributions to redefining the relationship between humanity and nature.

A Greener Festival Award

A Greener Festival is a nonprofit organisation dedicated to reducing the environmental footprint of music festivals and events. In 2007, they introduced the A Greener Festival Award initiative. Festival organisers can join this programme by paying a nominal fee, which covers the cost of audits. A Greener Festival assigns auditors to assess the sustainability measures implemented by festivals, evaluating their efforts to promote environmental friendliness. Award nominees are selected based on thorough evaluations conducted by trained sustainability auditors, including meticulous assessment, on-site visits, the presentation of supporting evidence, and in-depth analysis. Participating in this awards programme brings recognition and encourages events to undergo an Environmental Impact Assessment. This assessment fosters a deeper understanding of their environmental impact, promotes the setting of sustainability goals, enables ongoing monitoring, and encourages continuous improvement in environmental performance. These efforts benefit the environment and the events industry as a whole and give participating events a competitive edge, positioning them as leaders in embracing essential sustainability practices.

HOME - zero

Nesta and The National Gallery X (The National Gallery and King's College London) partnered to create a unique creative experience that aims to inspire a net zero carbon future. This initiative is part of Nesta's Sustainable Future mission, which seeks to reduce pollution from homes in the UK and to engage the public in addressing the climate crisis. The project involved collaborating with creative and

artistic teams to develop an experience based on the Gallery's collection in order to raise awareness of climate change and household emissions. The goal is to encourage cleaner, greener homes and highlight the importance of addressing household emissions, since the residential sector contributes significantly to UK emissions. As part of this initiative, they offered two R&D production commissions worth around £40,000 each, along with in-kind contributions from The National Gallery, King's College London, and Nesta. These commissions allowed two artists to develop experiences that were creatively ambitious, grounded in science and the Gallery's collection, and co-designed with target audiences. The project showcased two exhibitions designed to engage and educate the public about climate change and sustainable choices in homes, with positive feedback indicating increased awareness and appreciation for the initiative. This project began in September 2021 and ended in April 2022.

LAGI Competitions

The Land Art Generator (LAGI) is on a mission to accelerate the transition to post-carbon economies by showcasing models of renewable energy infrastructure that not only generate power but also enhance public spaces. The goal is to inspire and educate while ensuring that power access is equitable for households worldwide. To achieve this mission, LAGI hosts a biennial international design competition. This open platform invites creative minds from around the world to explore the essence of energy infrastructure and its potential in architectural form. Participants are encouraged to envision how such infrastructure can seamlessly integrate into urban landscapes, enrich public spaces, serve as educational tools, and spark inspiration. Over the years, this initiative has engaged thousands of individuals worldwide, resulting in the presentation of over a thousand unique and optimistic visions of a future powered by clean energy. The competition's design requirements are comprehensive, with a focus on the artwork's ability to harness natural energy sources, convert it into clean electricity, and efficiently transmit it to a grid connection point within urban settings. Safety for the public and potential on-site educational activities are also top priorities. Importantly, designs must be practical and feasible, not merely theoretical, and they must coexist harmoniously with the natural ecosystems of the chosen sites.

Quo Artis Award 2020

Quo Artis is an international non-profit organisation that serves as a bridge connecting art, science, and technology professionals. To commemorate its fifth anniversary in 2020, the foundation introduced its inaugural award, which is dedicated to supporting the research, development, and production of artistic projects that have yet to be realised. This award was opened to international artists and art collectives, both established and emerging, utilising a diverse range of materials and techniques to create groundbreaking and innovative artworks. The Quo Artis Award was created to engage with pressing contemporary issues and themes, foster experimentation and innovation in artistic practices, encourage new explorations at the intersection of art and science, and recognise artists who have demonstrated exceptional creativity and achievement. This inaugural award addressed urgent global societal challenges: PostNatural Histories; Anthropocene, Capitalocene & Biocene; Art, systems, and collective and emergent intelligence; Artificial intelligence, living systems, natural data, living machines, and synthetic life.

The Prix Pictet

The Prix Pictet's primary goal is to use photography, across all genres, as a tool to spotlight sustainability issues, with a strong focus on the environment. Established in 2008 by the Pictet Group, it has grown into a prestigious global photography award dedicated to sustainability. Over nine award cycles, each with a unique sustainability theme, nominees are selected by a network of over 300 nominators worldwide, resulting in approximately 4,700 nominations. Since its launch in 2008, the Prix Pictet has organised exhibitions in major cities worldwide, drawing over 550,000 visitors in total. The award is given to photographers whose work, according to an independent jury, excels both artistically and in the way it relates to the theme through storytelling. With each award cycle, a book is published and distributed globally. These books feature the work of shortlisted photographers and highlight impactful images from other nominated photographers.

WIN SUSTAINABLY! Nachhaltig gewinnen

The Austrian competition "Win Sustainably!" requires participants to meet specific sustainability criteria for public events. Events are expected to incorporate sustainable elements into their planning and execution, contributing to a more environmentally responsible approach. This includes considerations related to waste management, energy efficiency, resource conservation, and other sustainable practices. The submission process is retrospective, and events should occur within the specified time frame. Eligible participants include sport clubs, communities, agencies, religious communities, schools, and organisers of local or regional festivals and events. The competition includes categories for festivals, cultural events, sporting events, and sustainable sports clubs, with specific criteria for each category.

AFIELD fellowship

Through a fellowship and a mentorship programme, the AFIELD gathers and supports artists and cultural practitioners who develop social initiatives that benefit communities within and beyond the arts field. In the continuity of their artistic practice or as a step "further afield", selected initiatives enact positive, social, environmental, and political change in response to the needs of a community. AFIELD offers fellowships to artists and cultural practitioners who have initiated impactful social projects to foster lasting, tangible difference and empower their communities. These practitioners work in various creative disciplines as visual artists, filmmakers, choreographers, photographers, actors, writers, curators, and journalists. They all work beyond their traditional studios to benefit communities worldwide. The AFIELD fellowship is a monetary grant awarded annually to three artists and cultural practitioners who have initiated social projects catalysing change and empowering their communities in long-term and tangible ways.

Creative Power Award

The Creative Power Award was founded in 2020 by Rachel Hills and Simon Moss, two Australian culture creators in New York City. It is a small grants programme supporting creators at the intersection of art and social justice. Recipients receive up to \$2,000 USD / \$3,000 AUD, monthly mentoring sessions, and access to an online community. The award focuses on creative ideas fostering dialogue, shifting perceptions, and driving social change. Projects can be of various forms, and some winners address broader scope of environmental issues. Assessment criteria encompass the project's social impact and creativity, as well as the creator's potential to effect change, track record, and distribution plan. Eligibility is limited to emerging creators with incomplete projects.

S+T+ARTS Prize

S+T+ARTS, an initiative by the European Commission, fosters collaborations between technology and artistic practices, aligning with European policymaking to drive innovation while benefiting the arts sector. It emphasises individuals and projects addressing Europe's social, ecological, and economic challenges. One key component is the prestigious S+T+ARTS Award, which annually offers €40,000 in prize money. This competition highlights innovative projects at the intersection of science, technology and the arts, with a potential for significant impact on economic and social innovation. Two prizewinners receive €20,000 each and gain prominence at events hosted by consortium partners, including Ars Electronica, Bozar, Waag, INOVA+, T6 Ecosystems, French Tech Grande Provence, and Frankfurter Buchmesse. A jury analyses all nominations to decide on the two prize-winning projects and up to ten honorary mentions.

Young Climate Prize

The World Around, a public charity, is a global platform founded in New York in 2020 to engage the global design and architecture industry to enable positive change at scale. The Young Climate Prize, a biannual initiative by The World Around, combines an award and mentorship programme for individuals under 25. Its objective is to enhance and expedite the influence of climate-focused projects worldwide. The programme pairs 25 young climate leaders with global design and architecture community mentors. Three exceptional winners have the opportunity to present their work and ideas at The World Around's annual summit, hosted at the Guggenheim Museum in New York City. The prize connects a cohort of 25 talented young visionaries with international Design Champions in a bespoke, curated academy of talks, workshops, and one-on-one mentorship available in multiple languages.

Prince Claus Fellows Awards for Cultural & Artistic Responses to the Environmental Crisis

Since its establishment in 1996, the Prince Claus Fund has been committed to supporting arts and culture, particularly in regions facing challenges in Africa, Asia, Latin America, the Caribbean, and Eastern Europe. A key avenue through which the Fund accomplishes this mission is the Prince Claus Awards. These awards come in three categories, tailored to assist artists and cultural practitioners at different stages of their careers: Prince Claus Seed Awards, Prince Claus Fellows Awards, and Prince Claus Impact Awards. The Prince Claus Fellows Awards aim to empower mid-career talent, expedite socially engaged art practices, and facilitate meaningful connections among creatives addressing similar themes. Fellows receive €10,000 to invest in the further growth of their practice alongside opportunities to expand their work's impact. Structured into themed, regional, and interdisciplinary programmes, each in collaboration with a partner organization, the Fellows Award engages participants in year-long collaborative learning with carefully chosen mentors, guest speakers and workshops, both online and in person. One of the themed programmes is Cultural & Artistic Responses to the Environmental Crisis (CAREC), dedicated to 12 artists whose practice focuses on climate justice and its connection to social, racial, and environmental issues.
